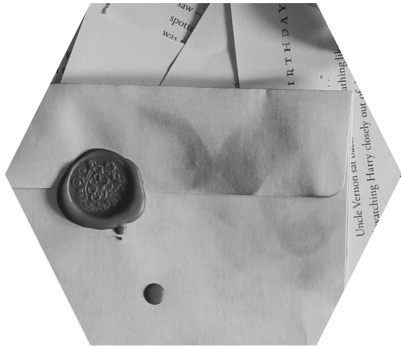

Each certificate has a unique Certificate Number which is verifiable on our website for authenticity. The certified standard appears clearly on each certificate and the scope of activities of the organisation is well defined.

All certificates carry with them Accreditation Logos. Also appearing are entity details of the Certification Body and the Accreditation Body, including their London registered company numbers and addresses. All certificates are attested by our Certification Manager.
